THE IMPACT OF FOREIGN TRADE ON THE AFFORDABILITY OF FOOD PRODUCTS IN RUSSIA

The article considers changes in the affordability of food products in the Russian Federation resulting from the alternations in the regulations of foreign trade in foodstuffs caused by the imposition of sanctions.

As an indicator of food affordability, the authors used the average number of minimal food sets that a consumer can acquire per month.
