# **Agreement on Scientific Cooperation**

between the Hanshin University Eurasia Institute (Osan, Republic of Korea)

and the Federal State Institution of Science «Institute of Economics of the Russian Academy of Sciences» (Moscow, Russian Federation)

The Hanshin University Eurasia Institute (Osan, Republic of Korea) represented by its Director, Dr. Jang-Hwan Joo, and the Federal State Scientific Institution «Institute of Economics of the Russian Academy of Sciences» (Moscow, Russian Federation) represented by its Director, Dr. Mikhail Yu. Golovnin, hereinafter referred to as the Parties, hereby conclude an Agreement on scientific cooperation in the areas of mutual interest related to the activities of the Parties.

### Article 1

The object of this agreement is to establish mutually beneficial forms of cooperation between the Hanshin University Eurasia Institute (Osan, Republic of Korea) and the Federal State Institution of Science «Institute of Economics of the Russian Academy of Sciences» (Moscow, Russian Federation).

Scientific cooperation between the Parties will take the following forms:

- carrying out joint scientific research related to the economic and socio-political development of Republic of Korea and the Russian Federation, cooperation between the two countries and various aspects of their international activities;
- organization of joint events on topical scientific issues of mutual interest (in the form of conferences, seminars, round tables, etc.);

- preparation and publication of scientific works based on the results of joint research;
  - assistance in publication of scientific works in both countries;
- parity-based reciprocal visits by the Parties' representatives, including their meetings organized to exchange information on the current status of bilateral cooperation and to identify promising areas for its development;
  - exchange of employees for study and research on topics relevant to joint projects;
  - assistance in purchasing scientific publications, exchanging scientific articles and other open information of mutual interest;
    - exchanging information on scientific events held by the Parties.

Parties may use other forms of cooperation that enhance the effectiveness of joint research.

#### Article 2

To implement projects, plans and protocols adopted pursuant to this Agreement, Parties may use their own funds and resources, as well as request subsidies and support from other institutions (including international ones) and individuals wishing to act as customers, contributors or sponsors.

### Article 3

The Parties to this Agreement shall have freedom of choice with respect to how they communicate with each other.

Information provided by either Party will be regarded as the exclusive property of that Party.

#### Article 4

Disclosure of information about cooperation to third parties not specified in this Agreement may be permitted only by mutual consent of the Parties formalized by a separate written agreement.

#### Article 5

If circumstances arise in the course of cooperation that may adversely affect the performance of the obligations by the Parties, they shall immediately inform each other in order to make coordinated decisions.

## Article 6

This Agreement is effective from the date of its signing by the Parties. The Agreement may be terminated if one of the Parties informs the other Party in writing of its intention to withdraw from the Agreement. In this case, the duration of the Agreement will be limited to six months from the date of the official written statement made by the Party withdrawing from the Agreement.

The Agreement is subject to revision or modification by mutual consent.

The Agreement is signed on <u>December</u>, 2022. The two original copies, in Russian and English, having equal legal force, will be kept by the Parties: one at the Hanshin University Eurasia Institute and the other at the Federal State Institution of Science «Institute of Economics of the Russian Academy of Sciences».
