The article, based on data from Rostrud and Rosstat Integrated Monitoring of Living Conditions of the Population, traces the dynamics of employment in unfavorable conditions, and categories of workers who are at greatest risk of ending up in hazardous production zones. Factors are identified and a connection is established between working conditions and certain aspects of the social well-being of workers. Problem areas that require state attention are substantiated: an increase in the share of those employed in heavy labor, the widespread occurrence of stressful situations at work and the omission of a significant part of occupational injuries by statistics.
